4TH ANNUAL OPPOSITES ATTRACT RULES

1. **ELIGIBILITY:** OPEN TO USBC SANCTIONED ADULT BOWLERS INCLUDING PBA & WOMENS SERIES MEMBERS UNLESS EXEMPT IN THE 09-10 AND/OR 10-11 SEASON. NO SANCTIONS AVAILABLE ON SITE.
2. **ENTRY DEADLINE: MAY 15, 2010;** NO WALK-INS ACCEPTED.
3. **LINE UP:** NO SUBSTITUTIONS WILL BE ALLOWED ONCE THE TOURNAMENT BEGINS.
4. **DRESS CODE:** POLO OR MOCK NECK SHIRTS, SHORTS OR JEANS. NO HEADGEAR, T-SHIRTS, SHORT SHORTS OR SHORT SKIRTS OR OFFENSIVE CLOTHING ARE PERMITTED. ANY BOWLER NOT ADHERING TO THE DRESS CODE WILL BE FINED \$20 PER ROUND. ALL FINES COLLECTED WILL BE ADDED TO THE PRIZE FUND.
5. **CONDUCT:** UNSPORTSMANLIKE BEHAVIOR WILL NOT BE TOLERATED. ANYONE USING ABUSIVE LANGUAGE OR ABUSING THE CENTER'S EQUIPMENT WILL BE SUBJECT TO DISQUALIFICATION.
6. **TIEBREAKER:** A TIE FOR 1ST PLACE OR THE LAST CUT SPOT WILL BE DECIDED BY A ONE GAME ROLL-OFF. ALL OTHER TIES WILL RESULT IN SHARING THE POSITION AND/OR PRIZE MONEY.
7. **PRIZE MONEY:** RETURNED 100% AT A CASH RATIO OF 1 IN 6.
